1) Your experiences of living in immigration detention, including the context and duration of your stay; I have ~~been~~ been in three detention's Colnbrook, Cansfield and Yarl's Wood they all are different I would say Coln Brook was worse staff is also rude on the other hand Cansfield was way much better staff is very good down there. Yarl's Wood is ok but healthcare is nightmare they never do good they lie about things don't give medicine.

2) The conditions in immigration detention, including your ability to access services such as legal advice, healthcare, pastoral support; Again Colnbrook is very bad ~~they~~ they broke my phone never get back to me and always hang up when I ring they lock us water come in rooms nobody do nothing they don't respect no privacy and make us look bad when someone complain Cansfield is very good they give you respect help you with whatever they can. Yarl's Wood ~~has~~ healthcare is very bad for everyone but for other things it's good for female's rather than male facility wise.

3) Whether there were appropriate mechanisms to deal with any mental, physical or emotional issues you may have experienced prior to or during your time in detention; My mum has medical issues and as I said Yarl's Wood healthcare is very bad and that cause people losing ~~the~~ their mind being here and not getting what you need cause more and more problems specially mental and emotional issues and many people go through this specially in places like Colnbrook where staff do nothing.

4) Any longer-term impacts of detention on you, your family and/or your wider community;

My mum has medical condition and her being here or anyone like her she very emotional and even a small thing and her blood pressure shoot up people like my mum shouldn't be in that sort of places if home office doesn't believe us that not our fault they reject everything we give within no time ~~they~~ they can't make someone's life decision like this she was never going to runaway but they still brought her here.
